An Open letter from Minneapolis Downtown Interfaith Senior Clergy May 26, 2020

We, the below signed members of the Downtown Interfaith Senior Clergy, condemn in the strongest possible terms the May 25th killing by a police officer of an unarmed African American man in Minneapolis.

As leaders of faith traditions that include Judaism, Islam, Roman Catholicism, Protestantism, and Humanism, we affirm our common conviction that *all life is sacred* and that every human being is our neighbor, worthy to be loved. Not killed.

Our hearts break, going out to the family and to those in our community who continue to bear the historical brunt of racially-motivated oppression that too often leads to violence and even death. In a press conference, Mayor Jacob Frey phrased it well: "Being black in America should not be a death sentence." We all say amen! We call for a swift response by city officials and Minneapolis law enforcement leaders, and a deeper addressing of the systemic issues that led to this and similar killings. We say "enough and more than enough!" Law enforcement *must* interact with *all* our neighbors in all our neighborhoods fairly and equally.

Might we finally learn from this most recent tragic incident? We must. We are all called to love our neighbors as ourselves.

Unitarian Universalist Association Appoints Rev. Ashley Horan as Organizing Strategy Director



The Unitarian Universalist Association (UUA) announces the appointment of Rev. Ashley Horan as the Organizing Strategy Director. The Organizing Director is called to strengthen the resilience of Unitarian Universalists, to organize for justice,

and express our faith through action. She will lead the five-person Organizing Strategy Team, including the Side with Love campaign, in its collaboration with UU and movement partners to advance the UUA's mission-based commitment to justice work and prophetic ministry.

Rev. Ashley Horan, continued

Rev. Horan comes to this new role after serving for five years as the Executive Director of MUUSJA, The Minnesota UU Social Justice Alliance, and seven years as core staff with the Beloved Conversations program. She has worked with nearly 100 UU, Christian, and Jewish congregations across the country to help faith communities build vibrant, effective justice ministries.

Rev. Horan grew up in St. Paul, MN, where she first felt the inklings of a call to ministry while participating in religious education as a child at Unity Church - Unitarian. After living for many years in a swath of cities from Boston to Seattle along the I-90/94 corridor, her heart and her home are once again in Minnesota. She lives there with her partner, the Rev. Karen Hutt; their two children (Zi - 19, and Aspen - 4); and a broad network of raucous, loving, chosen and biological family.

Rev. Horan begins this position on August 12. She has spoken to Groveland Fellowship several times in the past.

May 3 – Hildegard of Bingen Presented by Anne Sweeney



Anne Sweeney spoke to us about Hildegard of Bingen who was known for her visions, treatises, and musical compositions. She was also a major political player of the 12th century. Her letters reveal her attempts to

influence kings as well as other clergy, keeping them in line with the Church. Bingen was a powerful political force, unmatched in her age.

May 10 – The Disestablishing of Mashpee Wampanoag Tribe’s Reservation



Leticia Smith spoke to us about the Mashpee Wampanoag Tribe of Massachusetts and their efforts to preserve the newly acquired trust/reservation status of their land. As a result of Leticia’s program Groveland Fellowship decided to

support the tribe’s efforts by sending letters to our representatives and senators.

Leticia sent the following from the Mashpee Wampanoag’s website: “The court case that has postponed a US Department of the Interior order to disestablish the Mashpee Wampanoag Tribe’s reservation will be heard by the US District Court in Washington, DC, on Thursday, May 7, via video or teleconferencing due to the COVID-19 pandemic.” (However, I could not find information on whether the hearing was actually conducted, or when a decision might be forthcoming.)

There was also news that on May 19, an amicus brief was filed with the signature of 25 members of Congress with the Federal District Court for the District of Columbia. I’ll continue to check on the progress of the case over the summer. The postponement of the disestablishment is due to expire on June 7! I’m afraid it’s not very promising for the tribe.
